Landmark Economic Development Bill Signed into Law

Governor Charlie Baker recently signed House Bill <u>H.4569</u> into law. Authorizing up to \$1 billion in spending, the legislation sets aside funding for initiatives such as infrastructure, cyber-security, and MassWorks projects. 2779: MassEcon and the EDC of Western MA are working with an Albany, NY real estate firm representing a residential construction materials manufacturer that needs 20-80 acres to build a facility or will consider existing 500,000+ SF buildings. The company will employ 200 people with an average annual salary of \$70K. Notes: Locations being considered are western Massachusetts, northwest Connecticut, and upstate New York.

#2781: Project Vineyard: MassEcon is working with a location consultant representing a leader in a niche device industry. The proposed facility will act as both corporate headquarters and the center for research and development. The availability of a qualified workforce is the biggest driver in this location decision process. The company will employ 70 people in 35,000-45,000 SF. Notes: Foxborough is on the short list and is currently being evaluated.
