MassEcon, MassDevelopment, and MOBD are working with a Connecticut-based recycling company needing 40,000-50,000 SF of industrial/warehouse space with 24' clear. The preferred location is along the I-395 corridor. Notes: The company would like to be closer to their customer base in Massachusetts and they hope to eventually move their operation here from Connecticut.

#2540:

MassEcon and MOBD are working with a start-up biofuels company considering existing buildings and land sites for the potential of a maximum 100,000 SF processing facility. Municipal water/sewer, heavy power, and freight rail access are all needed for this project. Notes: The company would like to consider options statewide at this time.
