Active Projects

ID # 2290: A metal fabrication company needs 30,000 - 40,000 SF of industrial space to lease or buy with 18' clear ceilings with as few columns as possible for an out-of-state fabricated metal components company. The company would like to be located in Southeastern Massachusetts where the customer base is located.

ID # 2291: A manufacturing company is seeking 30,000-55,000 SF single-story, single-tenant facility in a 25-mile radius of Woburn to lease or buy. Requirements include 30'-40' Ceiling height, 2 loading docks, a minimum of 25 parking spaces, Phase 3 Power, and sewer service.

ID # 2294: A Bio diesel manufacturer is looking for 5-10 acres to lease or buy to construct a 40,000-50,000 SF custom built facility. The company would prefer both rail and port access, but would accept sites with just one of those components.

ID # 2295: A start-up manufacturer of hydraulic and braking systems for the wind turbine industry is seeking an existing 750,000 SF (+/-) industrial facility with at least 20' clear ceiling height on rail. Municipal water, sewer and natural gas must service the facility. No well, septic or propane. The facility must be able to meet their estimated electric demand of 20 MW or have the ability to meet this demand in a short period of time. This is a statewide search.

Susan Houston participated in the IT Collaborative Forum held at Microsoft's Massachusetts headquarters on June 10. The IT Collaborative was formed by the Commonwealth's Executive Office of Housing and Economic Development to foster crosscluster cohesion within the IT sector and is co-chaired by executives from Verizon and Cisco Systems. Susan also continued her participation this month as a member of the Manufacturing Task Force, organized by Barry Bluestone of Northeastern University and Don Walsh of Brockton 21st Century, to raise the level of awareness of the importance of the
