

MassEcon and MOBD are working with an in-state advanced materials manufacturer that would like to lease 20,000-40,000 SF. They need min. 28' clear in a portion (5,000 SF) of the building, min. 150 parking spaces, 1 loading dock, and 1-2 stories preferred, and 1200 Amp electrical service required. *Notes: At this stage they are considering space within a 40-mile radius of Andover.*

MassEcon was contacted by a Boston based real estate firm who is working with an in-state food processing company looking to lease or buy a 250,000 SF facility with 30+ acres for future expansion. They need 20 loading docks, 1 large drive-in door, min. 26' clear, open column spacing, and freight rail service provided directly by CSX.
